SERVICE APPLICATION - ROAD TYPE

This supplement contains new information that is not currently in the Operator Manuals.

Application:

For vehicles equipped with light duty brakes.

Service Application / Road Type

This vehicle is equipped with light duty brakes containing light weight stamped steel spiders. Due to these brakes, this vehicle cannot be operated in certain service applications and/or road types/classes. Read the information below before operating your vehicle.



WARNING!

This vehicle was only designed to be operated in limited service applications and road types. Read the following list of unapproved service applications and road types below before placing your vehicle into service. Operating your vehicle in an unapproved service application or road type could result in

an unsafe vehicle which may lead to personal injury or equipment damage.

Do NOT place vehicle into the following service applications:

- Logger
- Concrete Ready Mix
- Snowplow
- Mining Service/Hauler
- Crane/Cherry Picker
- Construction
- Agriculture
- Wrecker Service
- Heavy Equipment Transport
- Refuse Packer/Hauler
- Oil Field Well Servicing / Rig Move
- Fire Truck/EMT/Rescue Service
- Export on/off Highway
- Local Pick Up & Deliver for:
 - Tank Body
 - Beverage Body

Any other service application is acceptable so long as they do not operate in a Class C

or Class D road classification as defined below.

Class C or Class D Road Types - Not Allowed

Do NOT operate vehicle on any Class C or Class D road types.

Class C Well-maintained gravel roads or poorly maintained urban road conditions. Typical Class C road types are maintained gravel roads, broken concrete/asphalt roads, maintained logging or haul roads or farm roads.

Class D Off-road conditions, poorly maintained gravel, dirt or farm roads, farm fields, or extended operation on grades over 15%.

Primary (Class A) or Secondary (Class B) Type Road Services - Allowed

This vehicle is approved for use on any primary (Class A) or secondary (Class B) type road services.

**Primary /
Class A**

Well-maintained paved road surfaces of concrete or asphalt where vehicle can be accelerated to and operated at speed for extended periods of time. Grades encountered are 6% or less. Typical Class A operating conditions would be U.S./Canadian interstate or controlled access Federal or state highways.

**Secondary /
Class B**

Well-maintained paved road surfaces of concrete or asphalt with some grades over 6%, frequent stop-start cycle, or in urban/ suburban conditions. Typical Class B operation would be state or county secondary highways, urban pickup and delivery and mountain highways.
